# 4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料 所需的用途保留證券申請人及持有人的個人資 料。無需保留的個人資料將會根據《條例》銷毀 或處理。

#### 5. 查閱和更正個人資料

證券持有人有權確定本公司或香港證券登記處 是否持有其個人資料,並有權索取有關資料的 副本並更正任何不準確資料。本公司和香港證 券登記處有權就處理任何查閱資料的要求收取 合理費用。
